CODE OF ETHICS

I understand I must have respect to the material and people around me at all times. No behaviour or misconduct that can lead to discrimination to other members will be tolerated. That includes behaviours and attitudes due to cline, ancestry, place of origin, religion, marital status, family status, physical or mental disability, sex, sexual orientation or age of that person or that group or class of persons. Beware that there is a long written document called "Destreza Nova Laval Code of Conduct" that must be respected for any member to be part of our Club. Not Respecting such code can be reason of expulsion as a member of the club.

MARTIAL ARTS WAIVER SAFETY: The following represents a standard legal warning for all the students. A similar one can be found in any physical activity practiced around the world.

1. I acknowledge that martial arts are a potentially dangerous activity as any sport can be. Beware of the possibility of bumps, bruises, scrapes, soreness, sprains twists, related injuries or even severe ones causing death. I completely absolve Club d'escrime historique Destreza Nova Laval and any party acting on their behalf of responsibility for any injury I may sustain during any activities during any events or classes.
2. I acknowledge that physical contact with my body is both part of practicing and learning this martial art. The chest buttocks, groin, or any part of the body may be contacted by any part of the training partner's body during training of a specific technique or incidentally contacted while performing a martial arts technique targeting another portion of the body.
3. I understand that Instructors may adjust or manipulate any part of my body to assist in the proper application and understanding of a technique.
4. I understand that I have the right to withdraw from any exercise or drill for any reason and at any time.
5. If the conduct of an instructor or training partner appears inappropriate, the student should inform the director Andre Hajjar director privately. If the conduct of an instructor or any training partner appears criminal, then a director should be informed and the authorities may be notified either by the student or the director, or both.
6. I agree not to bring any claim or suit against Club d'escrime historique Destreza Nova Laval, instructors, staff, guests, students, landlord, or any other parties for any injury or harm sustained by any event short of a criminal act, and then only the criminal shall be the subject of such a claim. Finally, I shall indemnify Club d'escrime historique Destreza Nova Laval, instructors, staff, guests, students, and any and all additional defendants covered by this agreement for all judgments, costs, attorney fees and other expenses incurred as a result of a breach of this agreement.
7. If any clause, sentence, phrase or statement in this document is found unenforceable or invalid by any Court of law, the remainder of this document shall remain valid enforceable and the invalid clause, sentence, phrase or statement shall be considered struck from the document.

COVID / INFECTIOUS WAIVER: I understand that I should not participate in any activity if I fall into the next category:

1. Individuals who test positive for COVID
2. Individuals with symptoms such fever, cough, and shortness of breath among others.
